### Terms and conditions of restore commercial refrigeration

1. Rental agreement contract form must be completed with an ID/ID card or driver's license of the customer.
2. Delivery of the equipment & all collection of the equipment to the customer shall only be undertaken by the company unless the company in its sole discretion agrees otherwise.
3. Customer shall not at any under circumstances be entitled to move the equipment without the written consent from restore commercial refrigeration.
4. The customer shall be obliged to receive the rental equipment at the address or the premises whereby is agreed to be delivered or installed.
5. . Unless the customer or the designated representative of the customer accepts delivery under signature, the company shall not be obliged to effect delivery & in such incident the following shall apply;
  - Delivery shall thereafter be resulted at the company's discretion & the period of rental shall nevertheless commence from the original agreed delivery date.
  - All wasted delivery costs and any charges for storage, whether at the company's premises or not, occasioned by the customer's failure to accept delivery once agreed, shall be paid by the customer on demand.
  - Any additional costs incurred by the company caused by any unforeseen impediment to delivery, including but not limited to remote location, narrow/steep stairs, inadequate elevators, blocked access points and the like, shall be paid by the customer on demand.
6. Collection shall be on the agreed collection date specified in this agreement or on such late date as shall be agreed upon by the parties in writing.
7. The period of rental shall commence on the original delivery date and shall come to an end on the date that the equipment is collected by Restore Commercial refrigeration from the customer.
8. Ownership of the equipment shall at all times remain vested to restore commercial refrigeration.
9. In the event that the equipment is delivered to the customer at any premises which are rented by the customer, the customer shall be obliged to advise the lessor of such premises that the equipment is owned by Restore Commercial Refrigeration & the equipment shall thereby not be subject to any landlord's hypothec
10. The customer shall be obliged to have a comprehensive insurance cover in respect of the equipment for the period of rental and customer is liable for all risk of loss, damage, fire, scratch to the equipment from whatsoever cause may be arising from the time of delivery until collected by restore commercial refrigeration personnel. NB: Special security for the equipment is readily available at extra cost if need be at request.
11. 50% deposit is required when placing an order or booking a date & refundable amount of R500 is required from the customer to guard against any damage of the equipment & it shall be paid back to the lessee in seven days after when the equipment has been collected by the lessor.
12. Customer is requested to pay the balance amount in full 12 hours before delivery of the equipment
13. Our price includes deliver and collections in and around 40, anything more than 40km additional charges will apply as R8.90 per kilometer.
14. Upon delivery of the trailer Restore refrigeration representative should ask the customer to do a checklist of the equipment before is handed over to him/her & on the collection date of the equipment the customer would be ask to repeat the checklist to ensure that all are still in good condition .
